**Dear Sir/madam,**

As you continue to progress in your development of Plans of Management (PoMs), we would like to remind you of the resources available to guide you through each step. Read on for information on:

**Developing PoMs - which stage are you up to?**

Thanks to all councils who have been working with us throughout the various stages of the PoM development process. There is still some work to do, with 13 per cent of councils required to categorise reserves, and 74 per cent of councils yet to submit draft PoMs.

We have heard the concerns of councils regarding the deadline of 30 June 2021 for the submissions of PoMs. We have acted in response, and are preparing a regulation amendment to provide more time for councils to prepare PoMs. We hope to share an update with you on this in April.

Crown Lands is here to help and has a dedicated Council Crown Land Manager (CCLM) team to assist CCLMs in the development of PoMs.

As a CCLM, you can follow a four-step process while developing PoMs for Crown reserves within your local government area. These are:

1. Check which Crown reserves your council manages using the [Council CLM Reserves Portal](#).
2. Confirm community land classification of Crown reserves or seek operational classification if appropriate. You can access a range of resources to help you with this on the [Council Crown land manager](#) web page.
3. [Assign an initial category](#) for community land Crown reserves and notify the Minister using the template provided on the [Council Crown land manager](#) web page. If there are multiple categorisations across a reserve, you must provide a map delineating the categories with different colours. If you assign 'Natural Area' as a category, you will also need to indicate the sub-category/ies within the 'Natural Area' (i.e. watercourse, bushland, escarpment, wetland, and/or foreshore). You can view a [webcast](#) to help you with the Classification and Categorisation process.
4. Councils must prepare PoMs for all community land. View this [guideline](#) to ensure you are including all required information within your PoM. There are a number of forms, resources and templates to help you complete this process on the [Council Crown land manager](#) web page

### **Regional Events Acceleration Fund**

## Crown reserve in focus - the Bogey Hole, Newcastle

Hand-cut by convicts out of a rock shelf in 1819 for use as a personal swimming pool by the Commandant of Newcastle Major James Morisset, Newcastle's famous Bogey Hole is a sight to behold.

Managed by the City of Newcastle, the heritage-listed ocean bath is nestled into a cliff and framed by the expansive ocean blues of the Newcastle coastline, and when

the swell is big, is engulfed by crashing waves.

The name 'Bogey Hole' is said to come from the Dharawal word meaning 'to bathe', and as the oldest ocean pool on the East coast of Australia, it's well worth a visit for a dip, or simply to admire the majestic coastal views.
