# Record funding for annual reserves grants program

A record \$51 million will support more than 700 Crown reserves projects as part of the FY2020-21 <u>Crown Reserves Improvement Fund Program</u>. This grant round has included a \$40 million boost as part of the NSW Government's response to the econominc impacts of COVID-19. A range of projects will be supported contributing to the cultural, sporting and recreational life of hundreds of communities across NSW.

# New funding opportunities

#### **Indigenous Tourism Fund**

Aboriginal and Torres Strait Islander tourism business owners can apply for grants and access mentoring to help start up, diversify or grow their business, under the \$40 million Indigenous Tourism Fund. Applications close Monday 22 March 2021.

#### **NSW Environmental Trust Protecting Our Places Grants Program**

The NSW Environmental Trust is inviting applications to apply for grants of up to \$80,000 in the Protecting Our Places grant program. Funding is available to Aboriginal community groups and organisations throughout NSW for projects that encourage and empower Aboriginal communities to protect, conserve and restore cultural landscapes and waterways that are of importance to local Aboriginal communities. Applications close Monday 22 March 2021.

#### 2021 NAIDOC Grants

NAIDOC Grant funding is provided by Aboriginal Affairs NSW to support activities and events in NSW held during **NAIDOC Week (4 – 11 July 2021)** that celebrate Aboriginal and Torres Strait Islander history, culture and achievements.

The theme for this year is *Heal Country* and what better way to celebrate than to host a community event on a Crown reserve. There is also an opportunity to apply for some funding. Applications close Friday 23 April 2021.

#### **Regional Events Acceleration Fund**

To support the social and economic recovery of our regions, the NSW Government's \$20 million Regional Events Acceleration Fund will help organisations attract new major international and domestic events to regional areas, and support existing


regional events. Applications close on Friday 17 December 2021, or when funding is fully committed.
